Preliminary Report by Lead investigator Steve Sweet

Location

The premise is a 2 bedroom flat situated on the 2nd floor in a respectable street in North London. The building is home to 3 adults and 3 children.

Case Notes



The client had reported that family and friends had reported seeing the apparition of a woman in 50's clothing standing in the hallway. Strange feelings of being watched have occurred all around the property. Objects have been reported to move position and are often found in different places to where they had originally been placed.

Preliminary Investigation

Upon arriving at the location the team made their way to the flat and was warmly met by the client. As soon as we gained entry to the property and entered the hallway the team and I remarked that there was an intense pressure to the front of our heads. The team and I gathered in the kitchen and introductions were made.


A brief walk around was undertaken by the team to familiarise themselves with the layout of the flat and to deliberate any experiences and feelings that could be detected at the time.

Client Interview

I asked to speak to the client in a room away from the rest of my team to establish what activity had been experienced more clearly. Upon speaking with her in the front room she became emotional and tearful having to recount the numerous years of unexplained activity she and her family had encountered. The client indicated that the hallway and the children's bedroom were the most active areas in her home. the client then left the premises with her family to allow our investigation to begin.

EMF Sweep

Area 1 - Kitchen



The investigation commenced at 20.55 hrs. EMF checks were undertaken systematically by the team starting in the kitchen area. The kitchen being approximately 15-16ft in length by 9ft in width contained a vast amount of electrical appliances. The lighting was provided by 2 circular fluorescent tubes at either end of the kitchen ceiling. The EMF being emitted from both light sources was giving a reading of

between 80 Gauss and 120 Gauss on the MEL Meter display.

Area 2 - Front Room

The front room also contained a fluorescent light tube and when measured with the MEL Meter it constantly fluctuated between 95 and 120 Gauss.

Area 3 - Childs Bedroom Far End

The children's bedroom where much of the activity has been reported contained numerous electrical appliances. The ring main socket was approximately 2ft away from the upper bunk bed of one of the children, and would have been at head level when the child was laying down. This field alone was generating a constant exposure to high EMF's.

It was observed that there was a mains transformer from a wireless router present, and an EMF reading was taken from the supply which indicated a reading of 158 Gauss then a massive spike sent it off the scale indicating a massive level of exposure to harmful Electro Magnetic Radiation.



Area 4 - Middle Bedroom

The middle bedroom accommodated the clients' eldest daughter and Partner plus one small infant. EMF readings were conducted within the bedroom and indicated the night light device was pushing out a field of around 65-70 Gauss. There were numerous other electrical appliances in the bedroom which were also showing very high readings.

Area 5 - Hallway

The hallway readings were all within acceptable ranges. An EMF meter was placed against the wall where a field was traced along the wall outside the front door which led to a boarded up section of wall that contained wiring to all the flat(s).

Environmental Factors

The flat is located next to a busy junction to the main road which is a major intersection between the City of London and East London.

One possible explanation for the alleged paranormal activity in the clients' home may be caused by the build up of infra sound created by passing traffic combined with the added effect of high EMF exposure.

There are numerous pubs and shops which were trading at the time of Investigation, so EVP experiments were not deemed appropriate.

The average temperature in each room varied between 75 and 82 degrees Farenheight. This was possibly down to the electrical appliances being on and generating their own heat source. The flat is also on the top floor so as heat rises up through the building the temperature would remain warm.

The clients have two pet cats who were also present in the premises and any activity captured during the preliminary would have to be considered carefully to take into account possible contamination by the cats being present. Unfortunately they were indoor cats so could not have been removed.

Results

Far Children's bedroom

We started the Investigation at 21.15 by placing a HD Camcorder, Mel meter and voice recorder in the Far bedroom. All devices were switched to record for reviewing at a later time. Results: None

Front Room

The team gathered in the Front room with the lights switched off and consideration was given to the appliances that were left on.

There were 3 K2 Meters placed in different areas of the room and Bongos LED Trifield Meter was placed in the middle of the room along with a digital voice recorder.

The first EVP session and introductions were conducted by me. After exhausting all possible questions during around 20mins, I concluded that session and divided up the team into groups. The first group comprised of Matt and Debs and they were to conduct an EVP session in the Middle bedroom. Bongo and I entered the Far Children's bedroom and conducted a further EVP experiment using our digital voice recorders.

During the session the MEL Meter gave 4 continuous readings of 1 Gauss. This was conducted with the router still switched on to determine that the router was sending out a pulse of electrical energy when transmitting and receiving signals.

The router was then switched off and we continued with our EVP session.

Technique

I asked that if there was a spiritual presence in the room, if they could indicate their name by using the MEL Meter device to give a reading of 1 for a Yes.

As I went through all the letters of the alphabet, the MEL Meter showed no fluctuations and there were no readings or spikes in the EMF

In agreement with Bongo I concluded the session as we felt that the EMF fluctuations received earlier were all down to the electrical router signals polling.

Matt and Debs concluded their EVP session with negative results.

Conclusion

The clients were asked to return back to their flat as the Investigation was now complete.

Upon their return I spoke to the client and her daughter in their front room along with the team members present. I asked the client a series of questions.

The two main questions that were put to the client and her daughter were as follows:

1. Do you experience headaches, sickness, tiredness and lethargy?
1. Where in the flat do you feel these symptoms the most?

The answer to the first question was yes to all the symptoms, and the worst places to get the physical ailments were the kitchen where the 2 fluorescent tubes were located and in the front room where there was also a long fluorescent strip light.

I then explained to both clients in simple terms that the flat is full of EMF which resulted in their feelings of paranoia, sickness and hallucinations and with the MEL Meter I conducted the checks in their presence showing them the readings from the lights and how high the exposure is.

I then changed one of the fluorescent lights to an energy saving bulb and showed them the new reading from the MEL Meter that was just 0.5 mG to 1mG which remained constant as opposed to 80 -120 Gauss.

I informed the client and her family that the activity they have been experiencing was possibly due to the high EMF readings in their home and provided them with advice regarding electrical items being switched off when not in use, as did the other members of the GPS team.

The family was reassured that there is nothing paranormal in the property and that they need to focus on their electrical issues.

When presenting our findings to the clients there was a very emotional and relieved family. They seemed happy that answers were given to them at the earliest opportunity and there was nothing of a supernatural nature taking place in their home.

Lead Investigators Conclusion

As above the Family have been exposed to such high EMF exposure over the many years of living in the property. Now that an explanation has been given to them, the family are at ease and can make the necessary changes as advised to ensure they feel comfortable and happy in their own home.
